### WARRANTY PROGRAM 2009-2010

#### LIMITED WARRANTY

1. For the original owner only, Louis Garneau Sports Inc. guarantees, for five (5) years, each new rigid bicycle frame and fork against defects in workmanship and materials.
2. For the original owner only, Louis Garneau Sports Inc. guarantees, for one (1) year, each new dual suspension bicycle frame against defects in workmanship and materials.
3. For the original owner only, Louis Garneau Sports Inc. guarantees, for one (1) year, each new BMX bicycle frame and fork against defects in workmanship and materials.
4. For the original owner only of any Louis Garneau's bikes, Louis Garneau Sports Inc. guarantees, for one (1) year, paint and decals against defects in workmanship and materials.
5. Claims must be addressed with the initial proof of purchase to an Authorized Louis Garneau Sports Inc. Dealer and be treated by the latter in compliance with the return and warranty policies set forth by Louis Garneau Sports Inc.

**IMPORTANT NOTICE:** Louis Garneau Sports Inc. guarantees all original parts, excluding suspension forks and rear suspension unit, for a period of one (1) year from the date of purchase. (Suspension forks and rear suspension unit are covered by their manufacturers).

This warranty is not transferable and is limited to the repair or replacement of a defective frame, fork or part, at Louis Garneau Sports Inc.'s sole discretion. The warranty does not cover incidental or consequential damages, labour charges or individual costs incurred by the user or the dealer. Claims under this warranty are to be made through your dealer. Proof of purchase is required. The warranty does not cover normal wear and tear, improper assembly (assembly must be performed by an authorized Louis Garneau Sports dealer), damages and malfunctions resulting from abuse, neglect, improper maintenance, alteration, modification (for example: modifications to frame, fork or any components), accident, misuse, commercial activities, competitive events or bicycle races. The warranty does not cover damage due to abusive use such as winter riding on salty roads. **FOR EXAMPLE ONLY: Fatigue damage is a symptom of the frame being worn out through use.**

The user assumes the risk of any personal injury or damage to the bicycle or other losses if the bicycle is used at any time for stunt riding, dirt biking or similar activities, power or motor assist of any kind, competitive riding or anything other than normal use.
